## **PRIVACY POLICY**

Bloomberg L.P. ("BLP") respects the privacy rights of our users and is strongly committed to protecting your privacy online. This privacy policy applies to this Web site and does not apply to other products or services of BLP, its general and limited partners, and its subsidiaries, and their respective general partners and affiliates (collectively "Bloomberg").

### **Collection and Use of Personal Information**

BLP or a designated service provider collects personal information that you voluntarily provide on this Web site, which may include your name, address, e-mail address, etc. We use this information to communicate with you and to provide you with your requested service or product. Bloomberg may also provide you with information, special offers, and promotions. ### **Disclosure of Personal Information**

BLP may disclose your personal information to affiliates or unaffiliated third parties if we believe in good faith that such disclosure is necessary: (a) to comply with the law or in response to a subpoena, court order, government request, or other legal process; (b) to protect the interests, rights, safety, or property of Bloomberg or others; (c) to enforce any terms of service on this Web site; (d) to provide you with the services or products requested by you (including allowing a purchaser of BLP to continue to serve you), and to perform other activities related to such services and products, including billing and collection; (e) to provide you with information, special offers, or promotions from Bloomberg to which you consented; or (f) to operate Bloomberg's systems properly. ### **Accuracy and Security of Personal Information**

Any personal information you provide to BLP is kept on secure servers. BLP uses reasonable administrative, technical, personnel, and physical measures (a) to safeguard personal information against loss, theft, unauthorized use, disclosure, or modification; and (b) to ensure the integrity of the personal information.

### **Use of Cookies**

BLP or a designated service provider may use "cookies" or similar electronic tools to collect information to enhance your experience with this Web site.
